# **Terms And Conditions**



#### 1. Introduction

- All transactions are conducted directly between Users, and any disputes must be resolved between the buying and selling parties without involving Motoreast.

### 3.3. No Warranty or Guarantee:

- Motoreast provides the Platform "as is" without any warranties, express or implied, including but not limited to warranties of merchantability, fitness for a particular purpose, or non-infringement.
- Motoreast does not guarantee the success of any transaction or the accuracy of User-provided information.

### 4. User Responsibilities

- 4.1. Users are solely responsible for:
  - Verifying the identity, credibility, and reliability of counterparties.
  - Inspecting vehicles and confirming their suitability, condition, and compliance with legal and regulatory requirements before completing any transaction.
  - Ensuring that all uploaded information, including vehicle details, pricing, and documentation, is accurate and truthful.
- 4.2. Users agree to indemnify and hold Motoreast harmless from any claims, damages, or losses resulting from their use of the Platform or their transactions.

# 5. Payment and Financial Transactions

- 5.1. Motoreast does not process or facilitate payments.

- 11.2. Termination does not absolve Users of their obligations for any transactions initiated before the termination date.
